# Who is the course for?

- This course is for anyone interested in working as a Buyer, Purchaser, Procurement Manager, Supply Chain Consultant or in related logistics roles.
- Those applying for this course are required to be numerate and literate to at least level 2 (GCSE grade A-C) and have experience in a procurement or supply chain function at a managerial level.
- This is an intensive course and there will be a requirement to carry out extensive revision for examinations.



### **Programme Structure**

The course consists of five units:



Each unit will be assessed by examination (5 in total) and a period of 3 hours per exam will be permitted. Examination dates are set by the awarding body and will follow on directly at the end of each course.

Full membership is not available through completion of this qualification on its own, although it can be achieved through further commercial experience and/or continued Professional Development.

Those who complete the Level 4 Diploma may choose to go on and complete the Advanced Diploma or Professional Diploma.

On successful completion of the Diploma, Advanced and Professional diplomas and in conjunction with three years' experience in a role of responsibility in procurement and supply, candidates may apply for full membership of CIPS to use the designatory letters, MCIPS.
