Who is the course for?

- ◆ Those who have a full Cat B (car) Licence and are aged 18+ are entitled to apply for an LGV Licence.
- ◆ This qualification is suitable for anyone wanting to become a professional LGV driver after discharge.
- ◆ Successful candidates will be eligible to drive category C vehicles weighing over 3,500kg, with a trailer weighing up to 750kg.



Course Structure

Prior to booking

Prior to attending LGV Cat C Professional Driver Program all Service leavers require:

- ✓ A Full Cat B (Car) licence with provisional entitlement for Cat C added.
- ✓ A Pass on DCPC Part 1 Theory Test.
- ✓ A Pass on DCPC Part 2 Case Study Test.

Driver Training

- ✓ Hands on driver training delivered over a period of 5 days.
- ✓ Parts 3 and 4 Initial DCPC test on the final day
- ✓ Then apply for your full licence and DQC.

Post Training

- ✓ Contact Manpower Group to arrange your CWA or discuss employment opportunities in your area.
- ✓ Undertake civilian work attachment.
- ✓ Begin your new career as a Professional Driver.

What support will I receive?

- ◆ Prior to attending you will receive details on how to book parts 1 & 2 of the DCPC.
- ◆ During the course you will be accompanied by a qualified driving instructor each day. When you are not actually doing any practical driving you will remain in the lorry so that you can observe and learn from other students.
- ◆ The course will provide you with the practical capability and knowledge to complete parts 3 and 4 of the LGV Cat C test.
- ◆ Employment support and work attachment opportunities are available via Manpower Group should you choose.



Further Study

After gaining your LGV licence you may wish to gain further related qualifications. As the transport industry is highly regulated you will require further Driver CPC periodic. CTP delivers this and a number of related courses to help you progress in your chosen profession:

- ◆ Cat C+E Professional Driver Programme
- ◆ Driver CPC Periodic Training - A requirement for all commercial drivers
- ◆ ADR licence - A requirement for any driver pursuing a career driving fuel tankers or other hazardous goods vehicles (Driver CPC/ADR is available as a contract funded course with CTP)
- ◆ CPC (Road Haulage) International – For anyone pursuing a career as a transport Manager
